2.0 BRIEF SCOPE OF WORK

Engineering, Procurement and Construction and O&M for 10 years (02 years O&M for NRL) for the rooftop Solar Photo Voltaic (PV) project at Various Clients. The final plant capacity shall be as per the detailed engineering and approved design. The successful bidder shall be exclusively responsible for design, engineering, testing and all other relevant activities like preliminary visual assessment of Rooftop project , water arrangements, electricity, security and determining optimal capacity for setting up of Solar PV Plants and O&M activities for 10 years (for NRL, O&M shall be two years).

- 3.0 **Employer/Owner** shall intends to finance the subject package through External Commercial Borrowings, Domestic Commercial Borrowings, or its own resources.

Project Management Consultant (PMC): NTPC Vidyut Vyapar Nigam Limited (NVVN) shall act as the Project Management Consultant (PMC) for the Project. NVVN shall be responsible for publishing the tender and evaluating the bids, while the Contract shall be awarded by Employer to the successful bidder.

Note: Bidders are required to submit the Bid Security in favour of NTPC Vidyut Vyapar Nigam Limited (NVVN).

However, upon award of the Contract, the Successful Bidder shall be required to submit the Performance Security and all other requisite Guarantees in favour of Employer.

6.0 ELIGIBLE BIDDER FOR PARTICIPATION:

Only NVVN eligible enlisted bidders are invited to participate in this tender.

7.0 A complete set of Bidding Documents may be downloaded by any interested Bidder from the e-Tender Portal as per specified schedule. The tender is invited under e-tendering process. The bidders can enroll themselves on the website <https://eprocurementpc.nic.in/>. The use of Digital Signature Certificate (DSC) Class-3 key is mandatory for e-tendering activities. Accordingly, bidders should have Digital Signature Certificate (DSC) key of Class 3 to participate in e-tendering. Bidders, if required, can obtain DSC Class-3 key from agencies authorized by Govt. of India. The e-Tender Portal also has the user manuals with detailed guidelines on enrolment and participation in the bidding process.

8.0. Class-I local suppliers' and 'Class-II local suppliers' only are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

9.0. Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents.

Further, any bidder (including bidder from India) having specified Transfer of Technology (ToT) arrangement with an entity from a country which shares a land border with India, will be eligible to bid only if the bidder is registered with the same competent authority.

However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

10.0 Transfer of Bidding Documents by one intending Bidder to another is not permissible.

11.0 Downloading/Issuance of Bidding Documents and /or submission of Bid shall not construe that bidder is considered qualified.
